Further, Releaser hereby waives any and all such claims, damages, demands, rights of action or causes of action, for any injury, including, but not limited to personal, bodily, or mental injury, economic loss or any damage to releaser, releaser's spouse, guest, unborn child or relative. In addition, Releaser hereby agrees to release and forever discharge the Releases from any and all liability for any loss or theft, or damages to personal property. Releaser acknowledges that he/she has carefully read this Waiver and Release and fully understands that it is a waiver and release of any and all liability.

3: I agree that if, despite this release, I, my child or ward, or anyone on either's behalf, makes a claim against any of the Releases, I AGREE TO INDEMNIFY, DEFEND, SAVE AND HOLD HARMLESS THE RELEASEES and each of them from ANY LITIGATION EXPENSES, ATTORNEY FEES, LOSS, LIABILITY, DAMAGE, OR COST THEY MAY INCUR DUE TO THE CLAIM MADE AGAINST ANY OF THE RELEASEES NAMED ABOVE, WHETHER THE CLAIM IS BASED ON THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.

4: I have read this consent, release and waiver of liability, assumption of risk, and indemnity agreement, and understand that by signing it I give up substantial rights I and/or the minor or ward would otherwise have to recover damages for losses occasioned by the releases' fault, and sign it voluntarily and without inducement.
