Costume and Recital Information

To parents and dancers,

Enclosed is some very important information for our upcoming **Spring Dance Recital at the Pioneer Center for the Performing Arts, Sunday, June 17, 2018 at 3 p.m.** (In consideration of Father's Day, we are having an early recital.) We encourage that you invite your family and friends to this exciting performance! Theater seating is assigned and tickets are \$18 which includes the additional \$2 Pioneer per ticket fee and .9% tax on the ticket. To avoid online Ticket Master credit card fees, you are welcome to buy directly by going Pioneer box office. All ticket sales are through the Pioneer Center of the Performing Arts. If for any reason your dancer cannot participate in the Spring Dance Recital, please let us know through email at artinmotionreno@att.net by February 28.

Dancer's Commitment:

To participate, all dancers are required to fill out the costume information form, parents need to sign this agreement and a payment needs to be made. **Your dancer's recital commitments includes attending all dance classes, Dress Rehearsal (prior to show, dance times to be announced, between 10 a.m. - 2p.m.), and any other extra rehearsals needed.** Participating classes ages 3-6 will only attend the 2 p.m. call requirement unless instructor specifies differently.

Class attendance is very important, if a student misses 3 or more classes from April to June, they will be evaluated. If a student's attendance is in question, it will be up to Art In Motion as to whether they will participate in Recital. If an extra rehearsal is needed, an additional \$5 rehearsal fee will be applied.

Recital Fees:

Each Dance Class has a \$75 Recital Fee. This includes the recital fee, costume purchase, shipping and taxes. Ballet costumes and dresses for Lyrical and Contemporary may have additional cost. All XL and XXL sizes have an additional \$10 fee. You are welcome to pay the entire \$75 fee or use our accumulative plan. Payment can be made at our online store on our webpage, at the front desk at our main office or given to an instructor.

All City of Reno participants Recital Fee payments are to be made to Art In Motion directly. Class tuition is paid at City of Reno front desk. You must be enrolled in March, April, May and June months to participate.

Accumulative Payment Plan:

The Accumulative Plan consists of two monthly \$37.50 payments starting the first week of March. Example: If combining them with one class tuition, \$87.50 payment is due each month in March and April.

First Recital Fee payment is due with this Spring Recital Permission Form by March 1, 2018. All outstanding tuition and costume fees must be paid by May 15, 2018 for your dancer to participate. We order costumes grouped by class; delay in payment holds the class order until all payments are made.

Costume Sizing for Your Dancer:

It is up to the parents to measure and size your dancer properly on the Spring Recital Permission Form. We encourage that if your dancer is still growing, bigger is better.

Costumes must be ordered early to ensure that they are delivered on time for the performance. Some vendors take up to eight weeks for made-to-order costumes. Your instructor is responsible for costume choices. Often when ordering we find some costumes are not available due to high purchasing volumes beyond our control; if a costume is backordered and unavailable, your instructor will find an alternate costume to fit the needs of the choreography and dance.

Pre-planning is everything! The recital isn't a one day activity. With your help, we can make it run smoothly. This great opportunity should be fun for everyone. If you have any other questions that have not been answered by this letter, please call Art In Motion at 626-6235.

Costume payment is due with this form by March 1, 2018. If your dancer wears a large child then just put a large child on the form. **COSTUMES ARE NONREFUNDABLE and sometimes non exchangeable.**

We can help measure dancers but are not responsible for size choices. We encourage that if your dancer is still growing, bigger is better. **Art In Motion will not be responsible or give refunds if a costume does not fit.** If costume store allows exchanges, it is up to the parent to pay all extra shipping costs to make any exchanges. Common costs for exchange run between \$20 and \$30. **Only if you are unsure of your dancer's size, measure their chest, hips, waist and girth then look at the appropriate size chart to get their size before turning in your form.**

X-Large or XX-Large sizes may also be available and have an additional cost of \$10.
